Regional effort to focus on saving Land Conservation Program

Representatives from the nine counties, including members of the Boards of Supervisors, agricultural commissioners, planning departments and various agricultural organizations, met at the Fresno County Farm Bureau on Monday to learn of the status on the Williamson Act from the CA Department of Conservation and to discuss taking a regional approach to keeping the 37-year old program going. The participating counties include Fresno, Kings, Kern, Madera, Mariposa, Merced, San Joaquin, Stanislaus, and Tulare.

All of the county supervisors and agricultural commissioners expressed the important role Williamson Act plays in helping keep farmland in production. With the current pressures on farmers and ranchers, such as low commodity prices, inadequate water supplies and costly environmental regulations, any increased production costs -- such as increased land-based taxes -- could be enough to drive farmers out of production.

Nearly one-third of all private land in the state is under a Williamson Act contract, said Brian Leahy, of the CA Department of Conservation. More than 176,000 acres of farmland and grazing land were lost between 2004 and 2006 including 81,247 acres considered as prime farmland, Leahy said.

Counties can't cancel existing Williamson Act contracts, but they can initiate the process for a non-renewal, Leahy explained. It is a nine-year path, where the property taxes gradually increase each year. Either the landowner or the County may initiate non-renewal process.

If the local agency chooses to not renew the contract the landowner can protest the non-renewal and retain the full value of their Williamson Act tax reduction for four years until their property taxes begin to ramp up, over the following six years, to the non-Williamson Act rate, explained Leahy. If the city or county seeks to non-renew a contract, they must give the landowner notice at least 60 days prior to next renewal date, he added.

FCFB is urging Fresno County supervisors to continue the program. The Board of Supervisors likely will consider this item at a hearing on Sept. 22. For a full recap of the Aug. 31 meeting, see the September issue of *Agriculture Today*.

On Wednesday, Gov. Arnold Schwarzenegger vetoed the "card check" legislation, SB 789 (Steinberg, D-Sacramento). According to the Governor's veto message, "This process fundamentally alters an employee's right to a secret ballot election that allows the employee to choose, in the privacy of the voting booth without coercion or manipulation, whether or not to be represented."

New "California's Water" Segment will air locally on Friday

The latest segment of the "California's Water" series for public television will be shown at 7 p.m. on Friday, Sept. 4 on KVPT-Channel 18 in Fresno.

"California's Water Crisis" offers a first-hand look at the mounting toll of water shortages on the west side of the San Joaquin Valley this summer. Producer Huell Howser interviews a fourth-generation farmer who has fallowed 70 percent of his acreage due to shortages this year, talks with other growers struggling to keep tomatoes and almonds going and visits an extremely low San Luis Reservoir.

The segment also airs in Sacramento, Los Angeles, San Diego, and San Bernardino. The "California's Water" series is underwritten by the Association of California Water Agencies.

Large processing tomato crop predicted

Despite severe water shortages in critical tomato-growing areas, this year's processing tomato production is expected to top previous year's crops.

The USDA estimates California processing tomato growers will produce 13.5 million tons with an average yield of 43.97 tons per acre. The forecasted contracted production for 2009 is 13 percent above the previous record in 1999. Planted and harvested acres are forecast at 308,000 and 307,000, respectively.

Historically, Fresno County is a leading tomato producing county. In 2008, there were 109,000 harvested acres and 125,000 acres in 2007. This year, more contracted acreage was moved to where there was adequate water, including Kern and San Joaquin counties. The season got off to a good start when producers were able to get their crop in on time due to dry weather during spring.

California leads the nation in processing tomato production.

Continuing education courses available online

Fresno County Department of Agriculture in conjunction with the California Agricultural Commissioners and Sealers Association have launched a Web site to allow licensees and certificate holders to complete continuing education requirements mandated by the California Department of Pesticide Regulation (DPR) in the category of laws and regulations. All of the DPR-approved course work on this site is free-of-charge.

The courses are designed for the general public; professional applicators; pest control advisors and pilots; and all who employ pesticide handlers and field workers. The course provides an online explanation of laws and regulations, followed by a quiz to complete the course. After completion of the required course work, participants will be able to print his or her own Certificate of Completion as proof of course completion.
